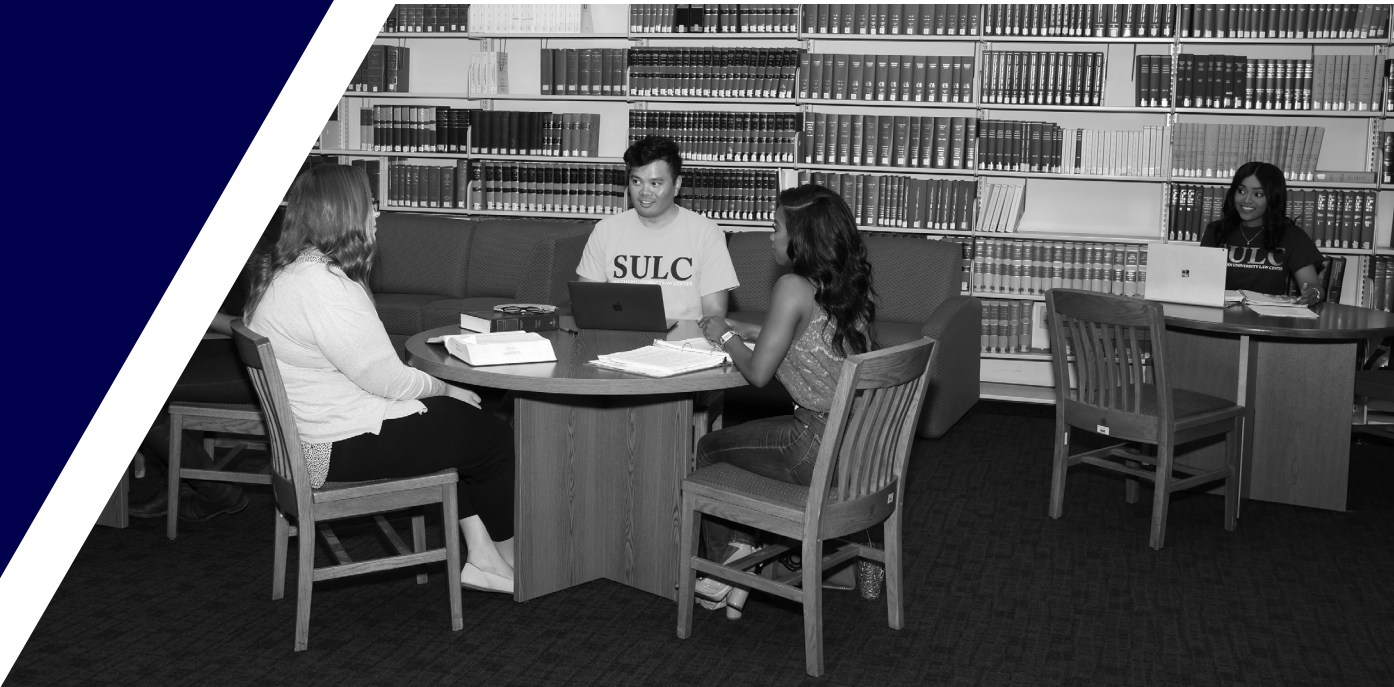

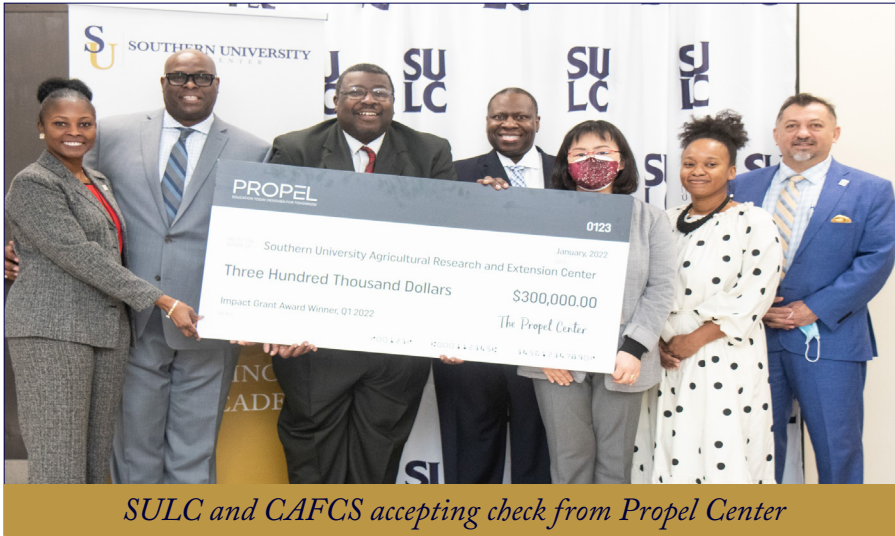

## SOUTHERN UNIVERSITY LAW CENTER AND SU AG CENTER/COLLEGE OF AG RECEIVED A \$300,000 CHECK FROM THE PROPEL CENTER

The Southern University Law Center and the Southern University Ag Center, College of Agricultural, Family and Consumer Sciences (CAFCS) received a \$300,000 grant from the Propel Center during a check presentation on January 26.

The proposal titled, Enhancement of Students' Design Hands-on Experiences through Computer Technological Support for the Quilt Laboratory in the Apparel Merchandising and Textiles

(AMTX) Program, was one of five Historically Black Colleges and Universities selected to receive an impact grant in Agri-tech.

The grant will upgrade the Quilt Laboratory in the Department of Family and Consumer Sciences Apparel Merchandising and Textiles program by integrating state-of-the-art technologies for quilting to improve the design of quilt patterns through the use of Apple's hardware toolkit. The project also aims to provide students with practical quilting experiences pertinent to business, design, and industrial applications including experience with home furnishing products.

The SU Ag Center and the CAFCS have partnered with the Southern University Law Center on this project. Drs. Seo, Samii Kennedy Benson, Assistant Professor of AMTX, and Renita Marshall, SU Ag Center Vice Chancellor for Academics and Student Support/Associate Dean of CAFCS (both co-project directors on the grant) will work along with Chelsea Grant, a Southern University Law Center student interested in fashion law.

The Propel Center is a first-of-its-kind innovation and learning hub for the entire HBCU community that leverages technology to advance education equity and transform the nation's talent pipeline and workforce. Through its funding partners Apple and Southern Company, the Law Center has developed a robust virtual learning platform with on-campus activations at partner institutions, and a physical campus set to be constructed in Georgia's Atlanta University Center in the Spring of 2023. ## THE SOUTHERN UNIVERSITY LAW CENTER HOSTS THE 2022 HAITI UNITY SUMMIT

The Southern University Law Center hosted a four-day Haiti Unity Summit January 14-17, in conjunction with the 2021 Haitian Diaspora Interest Group. The purpose of the summit was to provide a platform for the political factions and Haitian Civil Society to negotiate a permanent solution to the political crisis, and to lay the groundwork for a government of transition that will organize free and fair elections as well as practicable.

The summit closed with an action plan the Haitian political leaders can use to collaborate with the Accords in Haiti and help improve the government. The Haitian delegates left Baton Rouge with the next steps to establish an interim Haitian government by the Feb. 7 deadline, determine when the election will happen, and to make sure there is security in place.

General Russell Honoré, who led the summit, opened the last day of the summit by sharing a tweet from Fritz A Jean, the Accord Unitarie de la Louisiane's presidential nomination, asking for peace and unity as the country approaches the Feb. 7 deadline. Feb. 7 is believed to be when the term of assassinated President Jovenel Moïse will officially end. "There is hope that within the next few weeks leading up to the Feb. 7 deadline, the Accord Unitarie de la Louisiane can lead the way for a path forward with the Accords in Haiti, and there can be collaborations on all fronts," said Honoré.

Over the course of the summit, the delegates unanimously agreed upon one Accord, Accord Unitarie de la Louisiane, from nine different Accords. After two days of deliberation, the group decided a president and prime minister should run the country. Fritz A Jean was nominated as the next interim President of Haiti, and Mariam Fetiore, a female candidate for interim Prime Minister.

The Haitian delegates expressed their gratitude to Honoré and the SU Law Center for hosting the event. Many stated that it was a long and challenging process, but they managed to choose the right direction for Haiti. They are proud of the work produced at the summit. Some delegates shared how the democratic process is not easy but practical.

Honoré told the group and the Haitian people, "Remember your motto- strength and unity. You will survive together or fail separately."
