

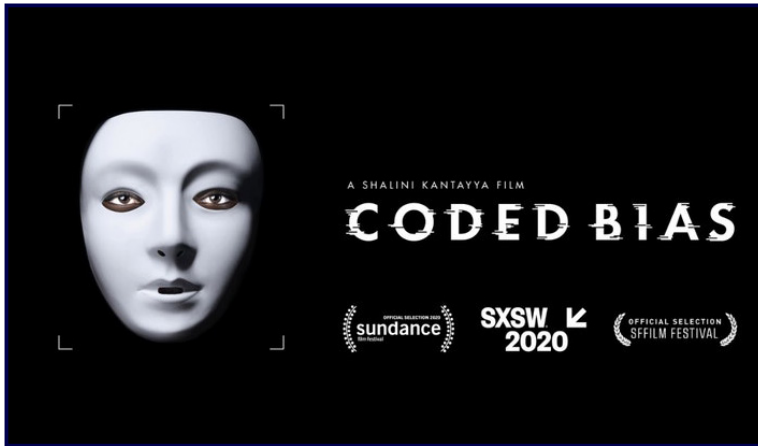

## ALUMNA HONORABLE JANICE CLARK INSPIRES LISTENERS WITH POWERFUL TESTIMONY

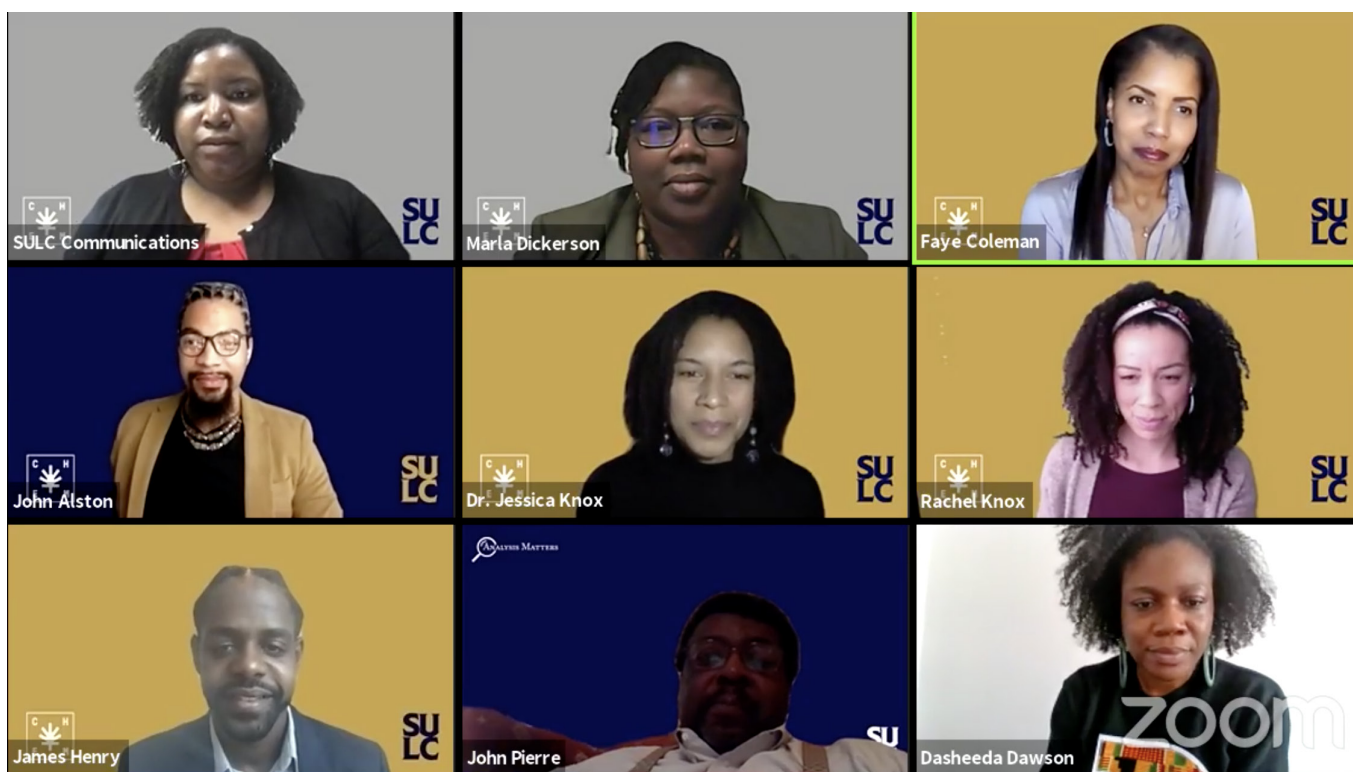
